### **GENERAL SUMMARY:**

Directs and supervises physical plant maintenance for the of all Texas Scenic Company (TSC) facilities, including our main headquarters, satellite offices, and production facilities. Directs and supervises maintenance of TSC fleet vehicles, ensuring compliance with local regulations and codes. Directs and supervises the compliance of all local, stage, and federal codes for all TSC facilities.

#### **ESSENTIAL FUNCTIONS:**

- 1. Ensure that the electrical and mechanical systems for all TSC facilities have all the electrical and mechanical infrastructure required to perform their function in a safe and cost-effective manner, including all required documentation. When required, maintains upgrades and repairs.
- 2. Ensures that the plumbing and HVAC systems for all TSC facilities have all the plumbing and HVAC infrastructure required to perform their function in a safe and cost-effective manner, including all required documentation. When required oversees upgrades and repairs.
- 3. Manages all TSC fleet vehicles are properly maintained per manufacturer's recommendations. Suggest to management when a new vehicle needs to be added to the fleet.
- 4. Assures TSC fleet are properly registered within the state where they are primarily operated. This includes maintaining toll tags, insurance, and roadside assistance for each vehicle. Maintains TSC fleet safety protocol documentation.
- 5. Maintains TSC list of authorized drivers and updates TSC insurance carrier of changes. Suggests to management when employees should not be allowed to drive TSC vehicles.
- 6. Ensure that all TSC facilities comply with local and federal hazardous waste reporting and regulatory requirements, including environmental regulations.
- 7. Manages the vast network of services for all TSC facilities such as janitorial, first aid, fire & safety, alarm systems, and lawn maintenance. Seeks and evaluates companies who provide the above-mentioned services and determines the best choice for TSC.
- 8. Comprehension of Safety Data Sheets (SDS) documentation and ensure that each facility maintains documentation relevant to their specific location.
- 9. Follow Corporate Policy as described in the Employee Handbook.
- 10. Follows and enforces all safety rules as described in the Shop Safety Rules.
- 11. Performs additional duties as required by management.
